**\*Note:**

Since January 1, 2015, the Treaty on the Eurasian Economic Union is in force.

Paragraph 3 of Article 97 of this Treaty applies to Member States (citizens of Armenia, Belarus, Kyrgyzstan and Russia).

At the same time, in cases of pedagogical, legal, pharmaceutical and medical activities on the territory of the Republic of Kazakhstan, it is necessary to go through the procedure of recognition of all workers of the Member States of this Treaty.

Also, all workers of the Member States of this Treaty should continue the recognition procedure if they continue their education.

This regulatory legal act does not apply to citizens of the Republic of Kazakhstan on the territory of Kazakhstan (clause 5 of Article 96: "worker of a member state" - a person who is a citizen of a member state, legally residing in the state of employment, of which he is not a citizen and in which he does not live permanently").

\*\*\* For other countries, regardless of the year of issuance of documents on education, there is no recognition procedure.

When applying for a state service, we kindly ask you to apostill them in advance at the authorized bodies in the country of issue.
